

## **Breeding contract Fresh Insemination Bacardi VDL**

Want to breed with the Stallion BACARDI VDL, UELN number 528003200601459 owned by

### **TOPS HORSE TRADING B.V**

(hereafter "STALLION OWNER"),

In consideration for breeding with the aforementioned stallion, the MARE OWNER agrees to pay the reservation fee of euro 250,-- (excl. VAT, transport costs and health certificates) **per dose** of fresh semen of BACARDI VDL, in full prior to dispatch.

The MARE OWNER must declare with a certificate signed by a veterinarian 45 days after the insemination, by doing a gestation diagnostic, whether the mare is in foal or not.

For every mare in foal a gestation fee of euro 1500,-- (excl. VAT) must be paid accordingly to the certificate issued 45 days post insemination.

The stallion owner does not guarantee a live foal born but only pregnancies. The STALLION OWNER is not selling single straws, only pregnancies.

One insemination dose consists of one (1) dose of fresh semen will be sent per contract.

Selling of any unused semen is forbidden, the customer agrees to pay the STALLION OWNER. The splitting of dose is strictly forbidden.

Doses cannot be sold to third parties and the semen can only be used to produce foals. Other reproduction techniques, including but not limited to OPU (Ovum Pick Up)/ICSI (IntraCytoplasmatic Sperm Injection), are forbidden without explicit written authorization of the STALLION OWNER and a separate contract being signed.

The transport of semen and the insemination of the mare will be at the MARE OWNER'S own cost and risk.

1 covering certificate will be issued per mare declared as per contract and if more than 1 pregnancy is declared on the 1<sup>st</sup> of October 2025 from frozen semen of Bacardi VDL, the MARE OWNER must inform the STALLION OWNER and will pay a gestation fee of 1500 euro per extra pregnancy.

The embryos will remain the property of the STALLION OWNER until the gestation fee for each embryo declared is paid in full to STALLION OWNER.

All living foals should be declared to the STALLION OWNER in order to receive birth certificates and any attempt to register a foal in any studbook worldwide without informing the STALLION OWNER will be considered as fraud.

Attempted fraud (including but not limited to the use of the semen for ICSI, resale of straws or Registering undeclared `extra foals`) committed by the MARE OWNER is punishable by an unconditional fine of euro 5.000- (excl. 21% VAT) per attempt, irrespective of the payable breeding fee.


Terms of the agreement: The agreement expires automatically after 99 years from the date of signing this agreement.

Governing Law: Any dispute arising from this agreement will be governed under Dutch Law and brought to the competent courts of 's Hertogenbosch, the Netherlands.
